Quick Reference Guide to Using the *psychprofiler*

If your entry point to *psychprofiler* is as a web user to complete an individual assessment then follow these 7 easy steps:

- Use your internet browser and navigate to: <u>http://www.psychprofiler.com/</u> Click on the menu "Complete the *psychprofiler* now" or the "click here" to be redirected to the *psychprofiler* assessment platform.
- 2. Click on Start New Assessment
- 3. Complete details on the person being assessed and the assessment type
- 4. Make payment
- 5. Complete the assessment by responding to the questions
- 6. Provide any other comments that may be relevant to the assessment (e.g. They were involved in a serious car crash three years ago.)
- 7. Receive the assessment report

If your entry point to *psychProfiler* is as a Multi-Use Licence owner then follow these 3 easy steps to provide an Assessment Token to the person who is to complete the assessment:

- 1. Obtain the *psychprofiler* Multi-Use Licence
- 2. Enter your Multi-Use Licence in the Assessment Platform home page and click 'Go'
- Select the required Assessment (i.e. Child and Adolescent, or Adult), the Assessment Type (i.e. Self, Parent, Teacher, Observer) and other details. Automatically deliver the single-use Assessment Token and hyperlink of the form to the person that is to complete the assessment (e.g. parent, teacher) by including their email address in the designated field.

Alternatively, put your email address in the field and supply the Token separately to them. The Assessment report at the completion of the Assessment Details will be returned to you via email through the email address you enter.

If your entry point to *PsychProfiler* is after receiving an Assessment Token then follow these 6 easy steps to complete the assessment:

- 1. Obtain the single-use Assessment Token from the Multi-Use Licence owner
- 2. Use your internet browser and navigate to: <u>http://psychprofiler.com/assessment/public/</u> Enter your single-use Assessment Token and click Go
- 3. Complete details on the person being assessed
- 4. Complete the assessment by responding to the questions
- 5. Provide any other comments that may be relevant to the assessment (e.g. They were involved in a serious car crash three years ago.)
- 6. Completion of the assessment, which includes automatically emailing the resultant assessment back to the owner of the Multi-Use Licence.

You may enter your response to each question by:

- Using a mouse to click on the radio button
- Entering a value of 0, 1, 2, 3, 4, 5 or 9
- Using the left or right arrows and the enter key.

After answering each question the screen will gently scroll to the next question.

There is no distinction between leaving a question blank and a value of 9 No Response.

None of the questions are mandatory, but obviously the more information you can provide the better the screening outcome.

Progress can be monitored in the area at the bottom of the screen.

When you have completed all responses, click Next.

Should you run out of time you may "Close and Return Later". This will save your data entry. You may return by entering your Token number at Step 2, or by clicking on the hyperlink in the email.

An alternate method of data entry is provided for quick entry when copying responses from a paper copy of the questions into $p_{sych}p_{rofiler}$.

Next you will be asked to enter the type of assessment, then details on the user and other information, following which a token will be generated for ease of use.

If you intend to forward the token to another person to complete the assessment questions (e.g. provide the token to a parent so they can assess their child) then the following steps may be useful:

- Enter "Select Assessment", then "Select Assessment Type" then "Email Address" and "Confirm Email Address" using the email address of the person to complete the assessment.

You need to "Select Assessment" then "Select Assessment Type".

It is not mandatory but you should also enter the email address (and the confirm email address which must be the same) to send the Token when it is generated. Typically this will be the email address of the person who will complete the assessment details, though an alternate approach is to email the Token to yourself, then forward the email to the person.

Also not mandatory, but recommended, is the email address to send the final report. Typically this will be you as the owner of the Multi-Use Licence Code.

There is also a Check box that will prevent display of the Assessment Report at the completion of the assessment. This is so that the Assessment Report is delivered to the medical practitioner and they can then review and discuss the report with the patient, rather than having the patient viewing the report prior to the medical practitioner and without proper medical guidance on interpretation.

The remaining details (name, address, phone, etc.) can be completed by the person that will receive and use the single-use Assessment Token.

After clicking Next the single-use Assessment Token is generated. The Token Number is shown on screen, and is emailed to the email address entered in the screen shown above. This is also the step where one of your Multi-use Licence Codes is consumed.

Detailed Guide for Using the *psychprofiler* Single-Use Assessment Token

Step 1: Obtain the single-use Assessment Token from the Multi-Use Licence owner

You will be provided with the single-use Assessment Token for completing the assessment.
